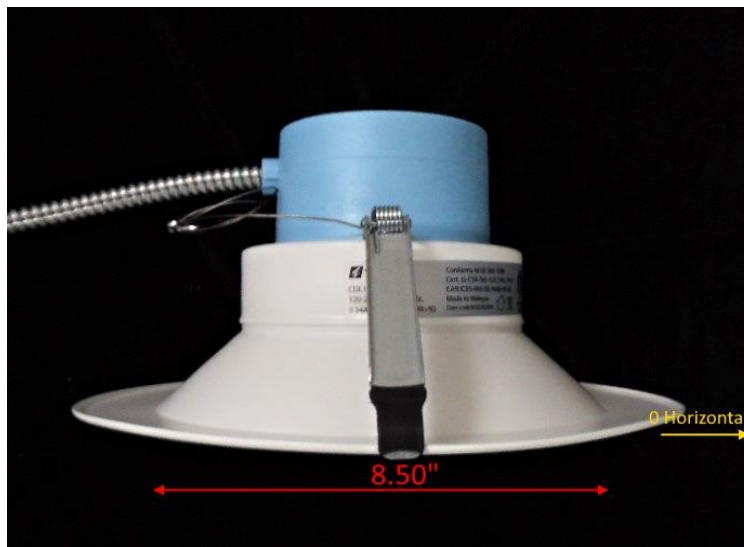

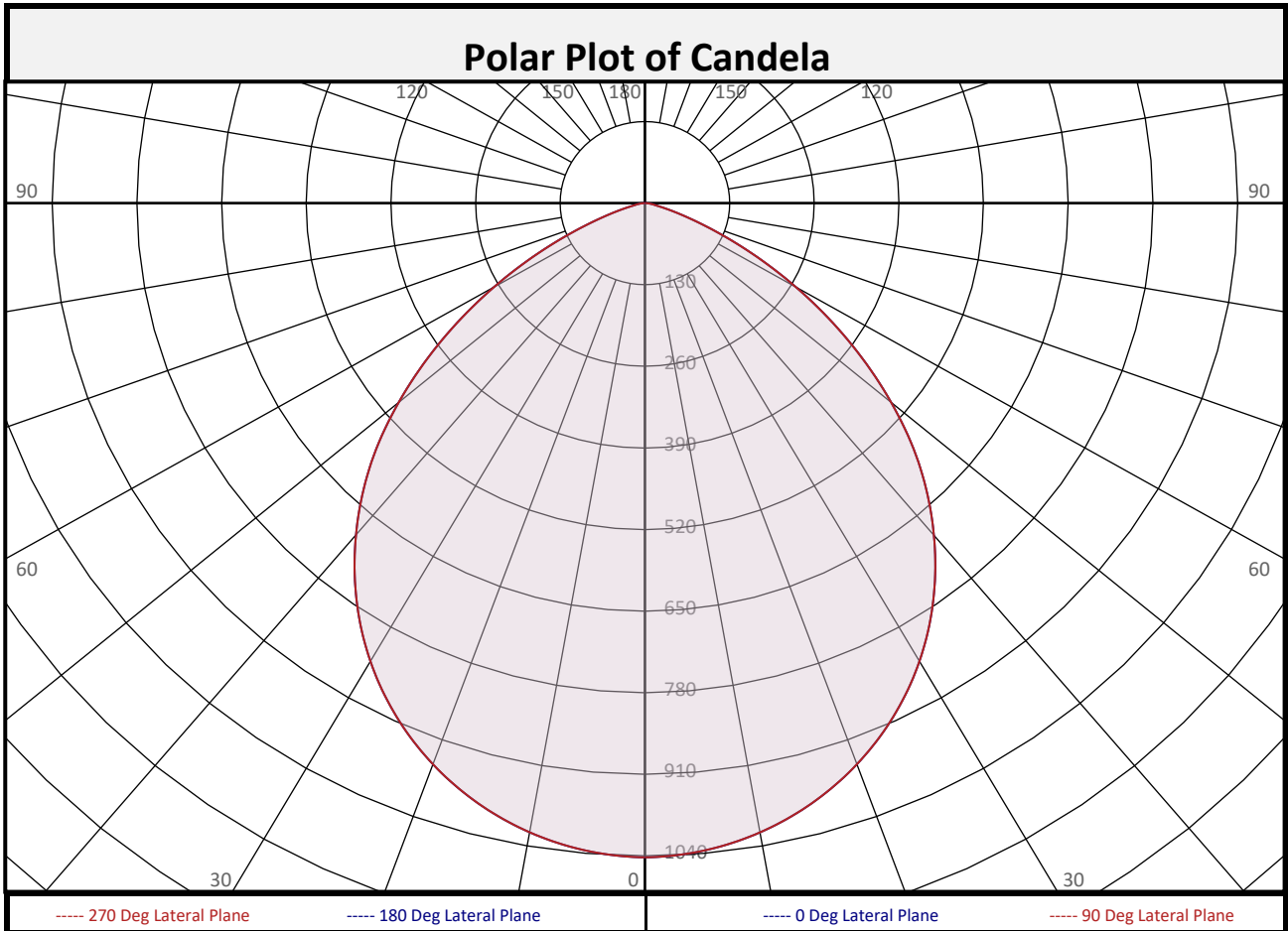

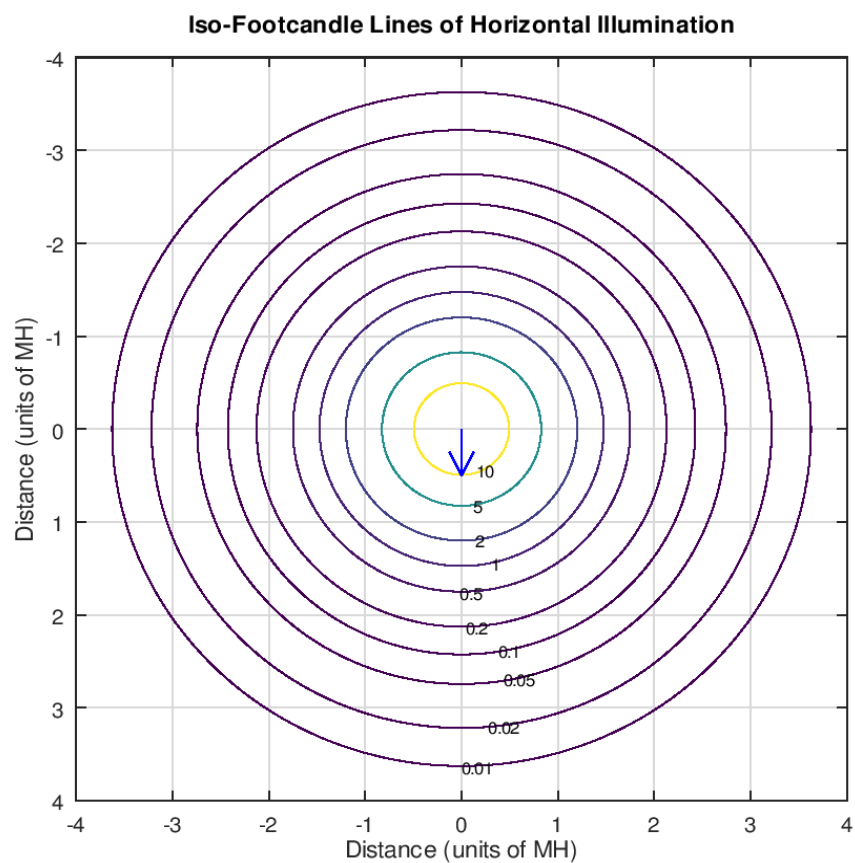

Iso-Illuminance Plot

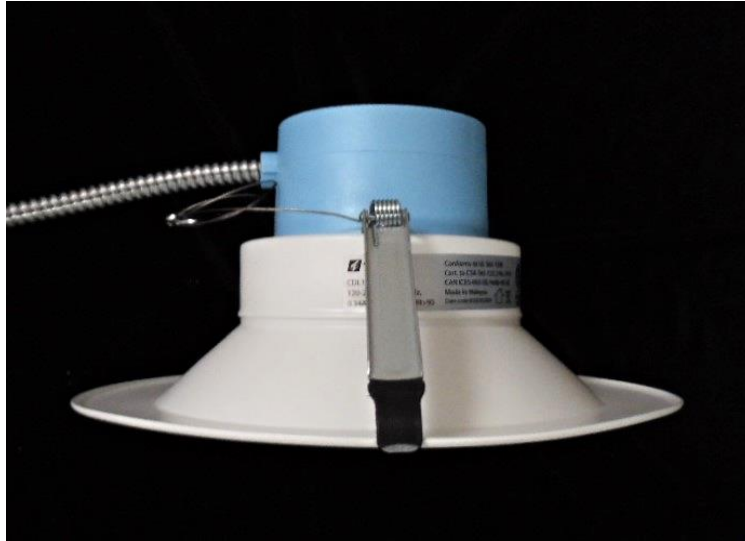
